Rural Agency for Community Development and Assistance (RACIDA) is inviting sealed tenders for the Supply and Delivery of hay balers as part of an ongoing project which aims to improve food security and livelihoods of disadvantaged communities living in the Gedo region, Somalia.

Tender's, who want to provide all, or part of the merchandise, will find general submission conditions and detailed description of commodities below:

#### **General conditions**

By participating in this tender, you are indicating your acceptance of the guidelines set out in this document. The commodities must correspond to the specifications of RACIDA conditions of contract and respect RACIDA's requirements as stipulated on the present call for tender. RACIDA reserves the right to disqualify and reject tenders from suppliers who do not comply with guidelines set out in this document.

## **General Bid Requirements**

- 1. Contact Information: Full name, address, telephone numbers of your company and contact persons.
- 2. Supplier's acceptance of RACIDA's Prohibition on Assistance to Drug Traffickers, and Certification Regarding Terrorist Financing Declaration (enclosed, Appendix I). RACIDA cannot issue a Purchase Order in the absence of a Supplier's acceptance of these declarations.
- 3. Prices: RACIDA will pay only for the goods actually accepted at the final destination after inspection at the unloading point(s) and deduction of actual damages and/or liquidated damages for late delivery and/or quality deviations if any. Applicants without this will not be considered.
- 4. Delivery time: The preferred delivery date/time for goods on-site is 2-weeks after receipt of RACIDA Purchase Order. Suppliers are therefore requested to quote their best delivery time in calendar days/weeks following receipt of the eventual Purchase Order.
- 5. Validity: Bids must remain valid with firm and fixed prices for 90 days after Tender Closing Date.

#### Special conditions

## **Delivery deadline**

Suppliers must indicate their delivery time. Once purchase orders and contracts are signed with the supplier, he/she must strictly respect the delivery schedules agreed. Delays or quantity differences in delivery without a valid explanation will incur a penalty of 10% of the total price.

### Acceptance of submissions of tender

Acceptance of submissions of tender is the sole responsibility of RACIDA. Any late submissions of tenders will not be accepted and will be excluded from the analysis.

#### Method of payment

The chosen supplier will be paid according to the terms of the contract: 100% of the total sum of each purchase contract will be paid upon successful delivery of the goods and services to the project location.

### Payment schedule:

The supplier will be paid 100% of the total contractual upon completion of the delivery and construction and after signing of the completion of work by RACIDA, with a limited delay of 10 days, if the materials and construction are accepted and the work is completed.

A bank transfer or Dahabshiil transfer into the suppliers' account will release the payment. No other means of payment can be considered.

#### Validity of submissions of tender

Quotations of submissions of tender must remain stable and valid for 90 days after the closing date for the submissions of tenders.

## Working language.

Communication, work documents and contracts will be drafted in English.

## Delivery bulletin.

Delivery note handed over by the supplier will be signed after the complete offloading of the merchandise in Dollow and Gedweyne district, Gedo region, Somalia, so that any possible damages may be recorded at this point. The tenders must carefully note: potentially damaged items will not be paid for by RACIDA and will be returned to the supplier if asked to at his/her own costs.

# **Control and Inspection**

RACIDA's representative can monitor the quality of commodities, their packaging, parceling, and storage at any time before the definitive acceptance of the offer. Quality control and inspection will be conducted by RACIDA upon loading at the supplier warehouse and upon receipt at destination in Dollow and Gedweyne district, Gedo Region, Somalia. The payments will be facilitated after the confirmation of goods at the target locations.

## Detailed items to be mentioned in the submissions of tender

- 1. Unit price and total price in USD of each commodity, including delivery DDP to RACIDA's project sites in Dollow and Gedweyne district, Gedo region Somalia. **Applicants without this will not be considered.**
- 2. Previous experience: The supplier must provide us with References of at least 3 important customers for the same or similar orders
- 3. Bank statements
- 4. The company registration and the national taxpayer registration number (Somalia bidders, if applicable)

- Tender's complete name and address, phone, fax and e-mail address.
- Tender's transporter name and address.
- · Official Certificate of registration of firm

## Order voucher and Contract.

If your submission of tender is chosen, a purchase contract will be signed.

#### **Cancellation clauses**

## Other cancellation clauses

If any conditions, in the invitation to tender or the supplier's application, change within the stated period, an additional Letter of Agreement must be agreed upon and signed by both parties.

Cancellation may occur where:

- 1. The tender procedure has been unsuccessful, namely where no qualitatively or financially worthwhile tender has been received or there has been no response at all;
- 2 The economic or technical parameters of the project have been fundamentally altered;
- 3. Exceptional circumstances or force majeure render normal performance of the project impossible;
- 4. All technically compliant tenders exceed the financial resources available;
- 5. There have been irregularities in the procedure, in particular where these have prevented fair competition.

In no circumstances will RACIDA be liable for damages, whatever their nature (in particular damages for loss of profits) or related to the cancelation of a tender, even if RACIDA has been advised of the possibility of damages.

The publication of a procurement notice does not commit RACIDA to implement the program or project announced.
